The Annual Health Econometrics Workshop

The annual health econometrics workshop (AHEW) provides a forum to discuss the use of econometric and other quantitative methods to address issues in health economics and policy, health services research, and outcomes research. It is the first meeting of its kind in North America and will facilitate the exchange of ideas among the growing health econometrics community.

The format of the workshop will follow the traditional structure of the American Health Economics Conference (AHEC), National Bureau of Economic Research (NBER) Conferences, and the European Workshops on Econometrics and Health Economics (i) a nominated discussant presents and appraises the paper, (ii) the author(s) responds, and (iii) open discussion follows. Each paper will be allotted one hour.

Participation in the workshop is by invitation only.

Keynote Speaker

Charles F. Manski, PhD

**Diversified Treatment
under Ambiguity**

This paper develops a broad theme about treatment under ambiguity through study of a particular decision criterion. The broad theme is that a planner may often want to cope with ambiguity by diversification, assigning observationally identical persons to different treatments. Study of the minimax-regret (MR) criterion substantiates the theme. The paper significantly extends my earlier analysis of one-period planning with individualistic treatment and a linear welfare function. I show that MR treatment allocations are fractional in a large class of planning problems with nonlinear welfare functions, interacting treatments, learning, and non-cooperative aspects. The paper discusses several applications to medical treatment and health planning. I study choice of a population rate of vaccination against infectious disease, when the external effect of vaccination on the health of the unvaccinated is not known. I compare learning using an adaptive minimax-regret criterion with learning from traditional randomized clinical trials. And I suggest institution of an adaptive drug approval process to replace the current FDA binary decision practice.

Biography:

CHARLES F. MANSKI has been Board of Trustees Professor in Economics at Northwestern University since 1997. He previously was a faculty member at the University of Wisconsin-Madison (1983-98), the Hebrew University of Jerusalem (1979-83), and Carnegie Mellon University (1973-80). He received his B.S. and Ph.D. in economics from M.I.T. in 1970 and 1973. Manski's research spans econometrics, judgment and decision, and the analysis of social policy. He is author of *Identification for Prediction and Decision* (Harvard 2007), *Social Choice with Partial Knowledge of Treatment Response* (Princeton 2005), *Partial Identification of Probability Distributions* (Springer, 2003), *Identification Problems in the Social Sciences* (Harvard 1995), and *Analog Estimation Methods in Econometrics* (Chapman & Hall, 1988), co-author of *College Choice in America* (Harvard 1983), and co-editor of *Evaluating Welfare and Training Programs* (Harvard 1992) and *Structural Analysis of Discrete Data with Econometric Applications* (MIT 1981). He has been editor of the *Journal of Human Resources* (1991-94), co-editor of the Econometric Society Monograph Series (1983-88), member of the Editorial Board of the *Annual Review of Economics* (from 2007), and associate editor of the *Annals of Applied Statistics* (from 2006), *Journal of Economic Perspectives* (1986-89), *Econometrica*, (1980-88), the *Journal of the American Statistical Association* (1983-85, 2002-04), and *Transportation Science* (1978-84). He has served as Director of the Institute for Research on Poverty (1988-91) and as Chair of the Board of Overseers of the Panel Study of Income Dynamics (1994-98). At the National Research Council, he has been Chair of the Committee on Data and Research for Policy on Illegal Drugs (1998-2001) and a member of the Board on Mathematical Sciences and their Applications (2004-2007), the Committee on National Statistics (1996-2000), and the Commission on Behavioral and Social Sciences and Education (1992-98). Manski is an elected member of the National Academy of Sciences, and an elected fellow of the Econometric Society, The American Academy of Arts and Sciences, and the American Association for the Advancement of Science.

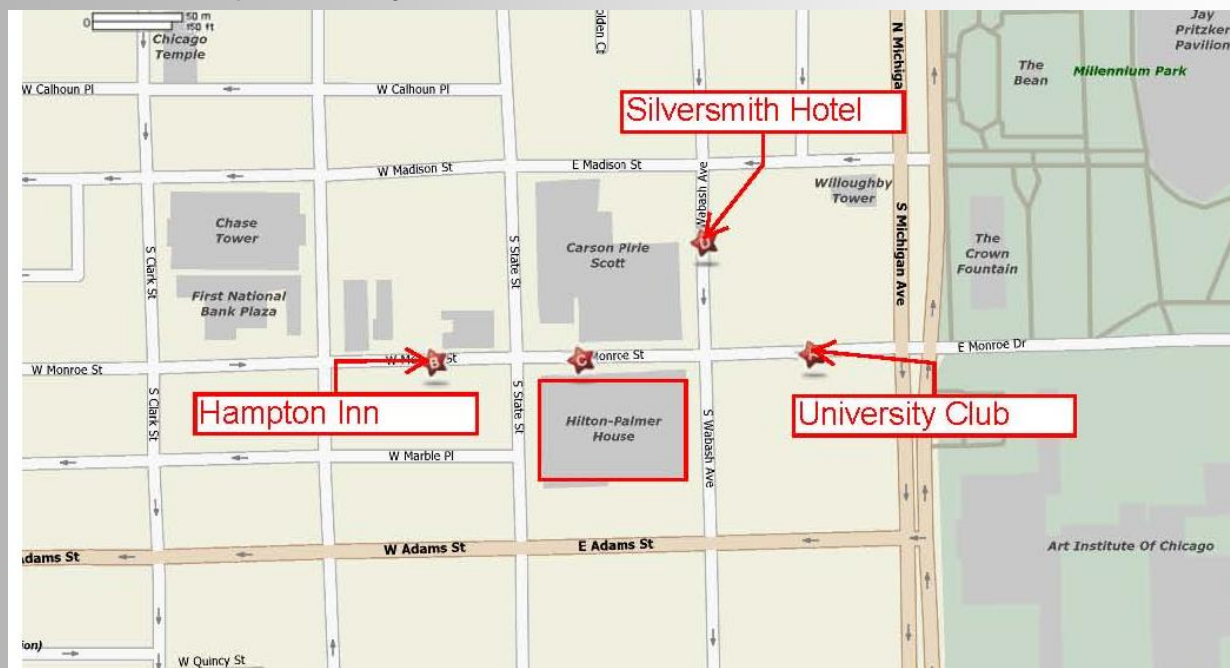

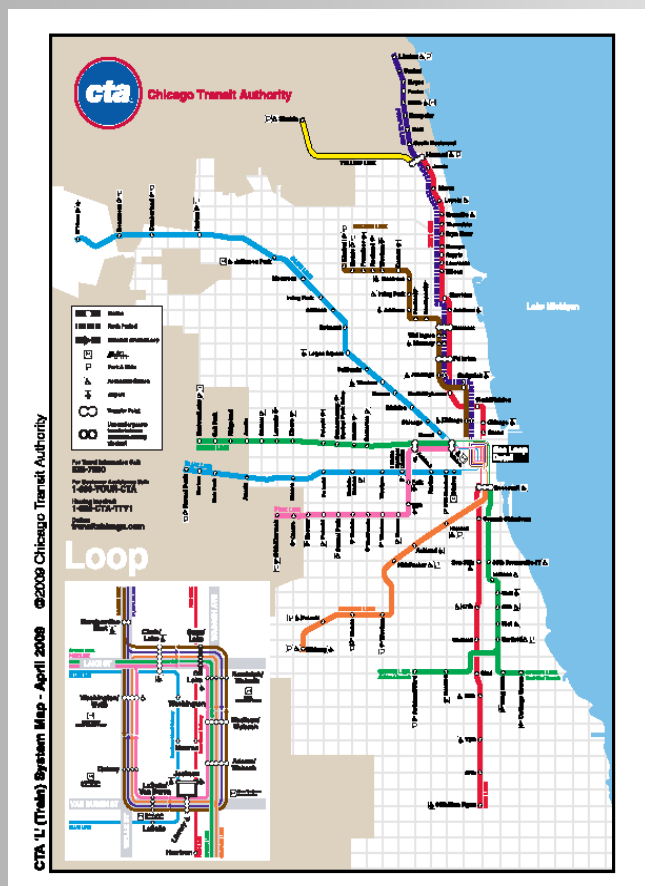
